SAFE OPERATING PROCEDURE

To be performed by the user before each use

1. Ensure that the trailer coupler is securely attached to the towing vehicle's hitch ball and that both are of the same size.
2. Ensure that the safety chains are crossed under the tongue and properly attached to the vehicle.
3. Verify that all wheel hub caps are securely in place.
4. Ensure that all lights are functioning properly.
5. Clean the trailer with water and soap. **DO NOT USE CORROSIVE PRODUCTS.**
6. Ensure that tire pressure complies with the manufacturer's recommendations.
7. Adjust the brake bands every 5,000 kilometers.
8. Grease the wheel bearings every 5,000 kilometers and check their adjustment after one week of use. Check the wheel lug nuts after the first use. Retighten the nuts after the first 80 km, in three stages, according to the specific model.
9. Tires 13": 50 to 75 lb-ft, Tires 14" to 16": 90 to 120 lb-ft.

The term "STANDARD MODEL" refers to a trailer whose dimensions or options are listed in the official catalog of Remorques Savage Inc. Remorques Savage Inc. reserves the right to determine whether the manufacture of a trailer model is considered standard or not.

Remorques Savage Inc. offers a limited warranty of ninety (90) days from the date of purchase to the original buyer. This warranty is non-transferable to a subsequent purchaser. It covers parts and labor for the entire trailer and its components.

This warranty shall not apply if the product has been damaged as a result of misuse, overloading, negligence, or use beyond its intended purpose. Remorques Savage Inc. reserves the right to inspect the product in order to determine whether it has been improperly used or if the usage constitutes abuse by the purchaser.

Remorques Savage Inc. warrants, for a period of ten (10) years from the date of purchase, the aluminum structure against structural or weld breakage, provided there has been no misuse.

Remorques Savage Inc. (Voltflex) also provides a warranty for a period of five (5) years from the date of purchase on the 12-volt electrical wiring.

EXCLUSIONS

- Certain components are not covered by Remorques Savage Inc., but rather directly by their manufacturer, including: axles, tires, rims, the hitch coupler, the winch, or any other part not manufactured by Remorques Savage Inc.
- Remorques Savage Inc. reserves the right not to apply the warranty if modifications are made to the trailer by the purchaser without prior approval. This includes, in particular, the use of chemical cleaning products not suitable for aluminum.
- Wooden floors are not covered, either by Remorques Savage Inc. or by the manufacturer.

WARRANTY APPLICATION

The warranty will be honored only if the repair is authorized by Remorques Savage Inc.

The purchaser wishing to make a warranty claim must present themselves at the office of Remorques Savage Inc., or at an authorized dealer, and provide proof of purchase.

All service, towing, or transportation costs are the responsibility of the purchaser.
